






I feel that the Learning Outcomes approach will help me in my teaching



General comments or concerns about the subject:

Although the learning outcomes are listed into highly measurable points, when assessing a language it is often difficult to focus on a single aspect and say if it is correct or not. For example Shopping 4. (Level 6): how do you define a 'simple' conversation? I believe that if we really aim to have a standard across all Maltese educational institutions, words like 'simple' 'main' 'complex' should be further defined or taken out altogether since what might seem simple to me might be deemed complex by another educator in a different learning situation.

General comments or concerns about the subject:

General notes: All the levels are divided in topics and sub-topics which makes it easier for the teacher to plan and understand the objectives written. Symbols are also used to explain the outcomes and make it easier for the reader to understand immediately which learning abilities are being tackled. Topics include ideas which teachers can use in class. Some of them are very interesting and very easy to adopt. Level 6 (year 6 level) was also included, giving the opportunity to the students to learn Italian from a younger age. Level 6 (Year 6) I would decrease the amount of work proposed at this level, bearing in mind that some topics might be too challenging for at this stage. I would remove topics such as food and drink and shopping and then include them at a later stage. I like the idea that culture was introduced at this level. It is important that from an early stage students start to get familiar with Italian culture and traditions. Level 7 (Forms 1 and 2) All the topics listed are the ones that we already cover at this level. However, here they are explained more in detail and the learning outcomes are included, with an introduction of some new ones. New topics: Healthy Living, Media and Technology: I would insert these topics at level 8. Some vocabulary is difficult and hard for students to understand. The same thing holds good for geographical locations which would be better at Level 8 where we apply directions. Me and my Neighbouhood: (9) and (10) and (15) can move to Level 8 where we tackle gradi dell'aggettivo and directions. Regarding the Home topic in Level 7 talking about one's house, rooms and different types of houses is adequate enough for this Level. In Leisure Time No 10 mention of voluntary work is more adequate for a higher, perhaps Level 8 or 9 Healthy Living should be tackled more in level 8 where in Level 7 description of the face and some simple parts of the body is enough for this level. Media and Technology I think no 2 is adequate enough for this Level The road to Italy - No 4 could be tackled more in Level 8 Level 8 (Form 3 and 4) All the topics listed here are mainly the same as those that we find in level 6 and level 7. This indicates that the students at this level will be building up on work covered during the previous years. This will give the opportunity to the weaker students for revision and also help the others to consolidate what they have learnt in the past years. No. 2 on School topic can be in Level 7 when one speaks about clothes Work and Money - 1, 2 and 3 could be included in Level 7 and Professioni e Lavoro in this Level No. 9 for Leisure Time could be more adequate for Level 9 In Media and Technology something on Cyber bullying can be introduced Road to Italy - No 6 more adapt to Level 9 Level 9 (Form 5) Even at this level we can find the same topics introduced in the previous levels. Expect one which is Work and Money. The amount of culture at this level decreased drastically. I would leave more culture topics at this stage and remove some of it from level 6 and 7. Some topics can also be tackled in Level 8 since time in Form 5 is very limited. Eg.
